DISCLAIMER CLAUSE

Social Sports, LLC, their officers, directors, agents, contractors, employees, volunteers, members and representatives (all hereafter collectively referred to as "the League") are not responsible for any injury, loss or damage of any kind sustained by any person while participating in Dodgeball or any social event, including injury, loss or damage which might be caused by the negligence of the League.

RISKS

In consideration of my participation in Dodgeball and any social event, I acknowledge that I am aware of the possible risks, dangers and hazards associated with my participation including the possible **risk of severe or fatal injury** to myself or others. I acknowledge it is my responsibility to obtain my own medical insurance.

INDEMNIFICATION

In consideration of the League allowing me to voluntarily participate in the Dodgeball season, I agree:

1. **TO ASSUME AND ACCEPT ALL RISKS** arising out of, associated with or related to my participating in Dodgeball or any social event, even though such risks may have been caused by the negligence of the League;
2. **TO BE SOLELY RESPONSIBLE FOR ANY INJURY, LOSS OR DAMAGE** which I might sustain participating in Dodgeball or any social event, even though such injury, loss or damage may have been caused by the negligence of the League;
3. **TO HOLD HARMLESS AND INDEMNIFY THE LEAGUE** from any and all liability for any damage to the property of, or personal injury to, any third party, resulting from my participation in Dodgeball or any social event;
4. **TO INDEMNIFY AND HOLD HARMLESS** the League, and each of its respective directors, officers, agents, contractors, employees, volunteers, members and representatives from any and all claims, demands, actions and costs which might arise out of my participating in Dodgeball or any social event, even though such claims, demands, actions and costs may have been caused by the negligence of the League.
